

RESOLUTION No. 605-25

A RESOLUTION DECLARING CERTAIN CITY OWNED PROPERTY AS SURPLUS PROPERTY AND AUTHORIZING THE CITY MANAGER TO SOLICIT SALE OF SAID PROPERTY.

WHEREAS, the City Council of the City of Donald is the authority in determining the need to sell a City-owned property that is no longer considered beneficial for public use; and

WHEREAS, the City Council has selected Public Works equipment consisting of a Case IH CX60 agricultural tractor as no longer beneficial for public use and should be declared surplus; and

WHEREAS, upon the declaration of surplus, the property is presented to City Council for action in regard to the terms of sale for the individual item declared surplus; and

WHEREAS, Oregon Revised Statutes and the City Charter and Ordinances authorize the City Council to dispose of surplus property no longer beneficial for public use; and

WHEREAS, the sale of the Property is in the public interest and will return the Property to productive use;

NOW, THEREFORE, THE CITY OF DONALD RESOLVES AS FOLLOWS:

Section 1. Declaration of Surplus. The following property identified below is hereby declared as Surplus Property.

- 1999 Case IHCX60 Agricultural Tractor - Serial number: CO6ORS3JJE1005098

Section 2. Authorization to Sell. The City Manager is directed to solicit the sale of said property by any lawful method.

Section 3. Method of Sale. The property may be sold by public auction, sealed bid, negotiated sale, or other lawful method deemed appropriate by the City Manager.

Section 4. Disposition of Proceeds. All proceeds from the sale shall be deposited into the City's General Fund or other appropriate account, less any administrative costs incurred in the disposal process.

Section 5. Effective Date. This Resolution shall be effective immediately upon adoption.
