## A RESOLUTION AWARDING THE MATTHIEU STREET PHASE 2 PROJECT TO HAYWORTH, INC.

**WHEREAS,** The Matthieu Street Phase 2 Project is planned capital infrastructure project to construct new street infrastructure to improve vehicular and pedestrian traffic for the community; and

WHEREAS, funding for this project is made possible through the City's Street Fund; and WHEREAS, the City of Donald invited General Contractors to submit bids to construct the Matthieu Street Phase 2 Project, which includes new sidewalks, ADA ramps, overlay along Matthieu Street south of Blake Court, and inlaying new pavement along Blake Court; and

**WHEREAS,** eight out of the twelve responding General Contractors submitted construction quotes under the engineer's estimate of \$450,000 based on the project's scope of work; and

**WHEREAS**, the Haworth, Inc. bid is the lowest of the ones received, and is otherwise qualified to be awarded the project.

### NOW, THEREFORE, THE CITY OF DONALD RESOLVES AS FOLLOWS:

**Section 1.** The City Council finds that the solicitation of bids for the Matthieu Street Phase 2 Project was conducted as per State procurement requirements.

**Section 2**. Haworth, Inc. is hereby selected as the General Contractor for the Matthieu Street Phase 2 Project.

**Section 3.** The City Manager is authorized to enter into a construction agreement with Haworth, Inc. to construct the Project.

#### RE: Recommendation of Award for the Matthieu Street Phase 2 Construction Project

Dear City Mayor and City Councilors,

The City of Donald (City) invited contractors to submit bids to construct the Matthieu Street Phase 2 project (project). The project includes new sidewalk, ADA ramps, overlay along Matthieu Street south of Blake Court, and inlaying new pavement along Blake Court. The City was required to publicly advertise for solicitation of a construction contractor as the estimated cost of construction exceeds \$100,000 in accordance with the Oregon Revised Statute (ORS) Chapter 279C.

Bids received were opened and read aloud at the Bid Opening Meeting held via teleconference at 2pm on February 2nd, 2023. We received bids from twelve construction contractors. The contractors and their bids are listed in Table 1. The engineer's estimated cost of construction was approximately \$450,000.

The bids were checked for completeness and accuracy, and all were found to be in order. The lowest apparent bidder is Haworth, Inc. (Haworth). The City Engineer contacted the Oregon Contractors Construction Board (CCB) and confirmed with them that there are no liens or claims against this business. Haworth recently completed the Matthieu Street Phase 1 and Blake Court Waterline projects satisfactorily.
