#### SEPTEMBER 12, 2023 CITY COUNCIL RECAP

The Donald City Council held their regularly scheduled meeting on September 12, 2023 at 6:45pm, where the Council discussed and, if needed, voted on the following agenda items:

- Presentations: Council heard a presentation from O.D.O.T. on Phase II of the Aurora-Donald Interchange project.
- Consent Agenda: Council voted 5-0-0 to approve the following items: August 2023 Action Agenda Summary, Fire Logs, Check Register and Cash Sheet. *Note: Due to technical difficulties, the*

- New Business I: Council voted 5-0-0 to appoint James Harden Jr. to the Donald Planning Commission with a term ending December 31, 2025.
- New Business II: Vote: Irrigation Water Use Agreement: This item was removed.
- New Business III: Vote: City Manager Contract Authorization Amount: Council did not make a motion and will continue discussion at future meeting.
- New Business IV: Council discussed the yard debris service proposal from N. Marion Recycling and Disposal.
- Added to Agenda: Council voted 5-0-0 to approve the Services Contract with McKillip Excavation, Inc.

#### UNDERSTANDING SULFUR IN DRINKING WATER

Sulfur bacteria can be found in many drinking water wells and household distribution systems. These harmless bacteria use natural sulfur compounds in water as a food source, thereby producing hydrogen sulfide. Although sulfur bacteria pose no health risks to humans, their presence in drinking water may cause objectionable tastes and odors. A water heater may also produce a sulfur odor, which resembles the smell of eggs.

Most methods for treating sulfur in water rely on the oxidation of hydrogen sulfide gas into elemental sulfur, a solid. Oxidation is the process by which soluble or dissolved elements are converted to soluble byproducts or insoluble products that can be filtered. Donald's treatment process removes some of the sulfur present in the water, but not all; therefore, small amounts are still present in the distribution system. The best way to eliminate the odor is by letting the water run momentarily, bringing fresh water into your house pipes or installing a water softener if your home doesn't already have one.

#### **BACKYARD BURNING**

According to Oregon DEQ regulations, it is against the law to burn anything other than yard debris, clean and untreated lumber, paper and cardboard, or woody debris anywhere in the state. It is also illegal to burn materials that have been transported from another property.

**Fall open burning season: October 1**<sup>st</sup> **through December 15**<sup>th</sup>. Burn season dates are subject to change without notice. Please call the Backyard Burn information line BEFORE you burn. To report outdoor burning on state-designated non-burn days or burning of illegal materials, contact DEQ.

#### DONALD MUNICIPAL CODE: 72.20 RECREATIONAL VEHICLE PARKING

Recently, the City has received several inquiries regarding recreational vehicle, motorhome, camper and travel trailer rules and regulations. Below are the rules in place to regulate recreational vehicle parking in Donald:

- A. No person shall park or place any presently occupied camper, motor home, or travel trailer at any place within the city of a period exceeding 6 hours.
- B. If the camper, motor home, or travel trailer is self-contained, the camper, motor home, or travel trailer may be parked or placed within the city for a period not to exceed 72hrs., unless an RV parking permit is applied for an issued by the City Manager.
- C. At no time will the camper, motor home or travel trailer be allowed to connect to any resident's water or sewer systems.
- D. Any other use of a camper, motor home, or travel trailer is expressly prohibited by this subchapter within the city.
- E. Use of any vehicle for sleeping quarters longer than the allowed period of 6 hours is expressly prohibited by this subchapter within the city.
- F. Use of a recreational vehicle that is self-contained is allowed for a night watchperson in the commercial or industrial zone only. A permit must be obtained from the City Manager at no cost to the owner of the property.

Occupancy granted under the RV Parking Permit shall not exceed 14 consecutive days. Cost: \$20
