

RESOLUTION No. 590-24

A RESOLUTION ADOPTING THE CITY COUNCIL AND PLANNING COMMISSION GOALS AND STRATEGIC APPROACHES. Repeals Resolution No. 574-23.

WHEREAS, the Council desired to review the City Council and Planning Commission’s Goals and Objectives for the purpose of visioning and to recognize the recent accomplishments; and

WHEREAS, the City’s leadership places high value on having City goals to give clear direction regarding the City’s priorities and vision for the elected leaders, appointed officials, city staff, volunteers and residents and businesses to follow; and

WHEREAS, the City Council and the Planning Commission met with the City Manager in a Goal Setting Meeting on April 1, 2024 to review the existing goals and set new goals and strategic approaches; and

WHEREAS, these goals should be used in the preparation, review, and adoption of the City budget; and

WHEREAS, these goals and objectives should be evaluated before applying for grants or expending City resources.

NOW, THEREFORE, THE CITY OF DONALD RESOLVES AS FOLLOW:

1. The City of Donald City Council hereby adopts the City Council and Planning Commission Goals and Objectives as attached in Exhibit A.
2. This resolution is effective immediately upon its enactment by the City Council.

City Council & Planning Commission Goals – 2024-2025

A. Public Safety, Health & Well Being (Priority No. 1)

Strategic Approach: Leadership will work to ensure the health and safety of our community through enhancement of patrols and enforcement through police services, emergency planning and recovery that includes creation and implementation of an emergency response plan, community involvement through CERT qualifying, coordination with outside agencies, plan implementation, identification of resiliency centers, community-wide events, promotion of health and literacy, education through available media, parks master planning; park enhancements that include restroom facilities for the basketball court at the skate park, Donald's Hometown Park playground resurfacing, dog park and picnic areas, trail additions, and future park land.

B. Secure & Reliable Infrastructure

Strategic Approach: As it relates to priority number one, secure and reliable infrastructure will be accomplished by maintaining service levels through construction of a new drinking water well and expansion of wastewater facilities, identifying funding options for infrastructure master plans including water and sewer, creating a street maintenance schedule and in support of the Street Survey, and continuously identify grants and other funding sources that help offset the costs of constructing infrastructure improvements.

C. Access & Mobility

Strategic Approach: Accessible services and enhanced community mobility will be accomplished by establishing a transportation network that creates opportunities for the community to utilize alternate modes of transportation, partnering with local vendors that provide transportation options, adhering to sidewalk standards associated with development, constructing sidewalks east of the railroad tracks, propose crosswalks where feasible, utilizing and supporting the Street Survey, and accessing grants for related projects as necessary to offset construction costs.

D. Economic Sustainability & Resiliency

Strategic Approach: A thriving, sustainable, and resilient local economy will be accomplished by fostering a business-friendly environment, working with local leaders to diversify business opportunities, establishing a community identity recognizable as Donald, commencing a history program, creating a business recruitment strategy, and working with property owners to obtain property information prior to demolition of structures.

E. Climate Action

Strategic Approach: A clean, healthy, and sustainable environment is crucial and the City's commitment to climate action will be exemplified through city-wide clean-up efforts, maintaining the City's Tree City USA designation, protecting natural resources, exploring a Main Street streetscape tree donation program, developing a tree planting strategy, monitoring and evaluating energy usage levels of City operations, and working with development interests to implement green building practices, policies, and education.

F. D.E.I. (Diversity, Equity, and Inclusion)

Diversity, Equity, and Inclusion is a commitment to increasing diversity in all City operations; working collaboratively to provide equity and equal opportunity for all persons by challenging bias, harassment and discrimination, and a deliberate pursuit to respectfully acknowledge and welcome differences in a manner that creates a vibrant climate of inclusiveness and belonging. This commitment applies to all people regardless of race and ethnicity, gender and gender identity, sexual orientation, socioeconomic status, language, culture, national origin, religious commitments, age, disability status, and political perspective.

Strategic Approach: This goal will be accomplished by fostering and recognizing community-wide spirit through access to government services and programs, community events and volunteerism such as local festivals and a volunteer appreciation event, support of the Donald Festival Committee, City-wide clean-up efforts that include an Adopt a Street Program and Clean-up Day, new resident/business welcome programs, literacy programs, and access to programs that seek to enhance health and nutrition.
